- 2. There should be condition that vehicles park on site and not on the road which currently happens. The proposed annexe is sited close to the cross roads junction and there is no pavement along Heath Road. Parking in the road poses a safety issue.

5. PLAY AREA

- 5.1 Monthly inspection report. Mrs. Fullam will carry out an inspection.
- 5.2 Quotations for Refurbishment of the slide mound. Mrs. Fullam presented the three quotes Urban Forestry £2370.28, Proscape £1590, and Dan from Eastern Play £1855. After reviewing the specifications, Mr. Aket proposed the Council accept Eastern Play to carry out the refurb, Mrs. Mathieson seconded, with all in agreement. Mrs. Fullam agreed to contact Dan to find out when he could commence the work.
- 5.3 The Clerk will enquire about play bark for the Play Area.
- 5.4 Mrs. Fullam showed a variety of rubbish bins for the play area. The colour agreed upon was yellow to try and highlight the usage, with one by each gate.
- 5.5 Mr. Aket expressed concern about the number of dogs allowed to run free on the playing field. Mr. Burt enquired about signs and Mr. Aket agreed to investigate.
- 5.6 Mr. Burt enquired about ownership of the hedge and ditch alongside the playing field path. Mrs. Mathieson confirmed it was owned by Mr. Honeywood.

6. CORRESPONDENCE for discussion

- 6.1 Mid Suffolk District Council final recommendations on the new electoral arrangements noted.
- 6.2 Suffolk Highways update on carriageway repairs. Mr. Etchell-Butler commented on the Highways policy which appeared to be a temporary repair and then return later for a full repair.
- 6.3 Road closures. Mrs. Fullam expressed concern at the number of times there has been a road closure along Ashfield Road. She felt there should be an indication of where the road is closed as the closed sign could be some way from the works. Highways will be contacted about the concern of the Council.
- 6.4 Councillor Achievement Awards. Mr. Aket proposed that the Council should nominate Mrs. Mansell who attends every meeting, shows dedication, is approachable, not politically pushed and will answer all queries asked of her. Mr. Etchell-Butler seconded the proposal with all councilors in agreement.
