| 4. | <p>REPORTS FOR INFORMATION</p> <ul style="list-style-type: none"> •Report from County Councillor Jane Storey - noted <p>Mr. Aket enquired about C.C. funding to help families in need over the Christmas period. Mrs. Storey stated there are advice lines set up, but she felt help would be set up but this had as yet to be confirmed. Suffolk Community Foundation can give grants, i.e for heating oil.</p> <p>Mrs. Storey outlined her reply to the email from Councillor Turner about the Highways Locality Budget. She replied that a dedicated pedestrian crossing on the A1088 is not something the Speed and Safety Dept could fund at this time. Such a crossing would need to be traffic light controlled and not a zebra crossing and the cost of the traffic regulation order, electric work and other necessary infrastructure would increase the cost to in excess of £30,000 so would not be feasible for the Highways Budget as an alternative to SCC direct funding. She mentioned a pedestrian refuge but the cost of this would be approx. £10,000 but the road may need to be widened. Mrs. Storey recommended the installation of Vehicular Activated Speed signals or the warning flashes that can be manual or time set to school times and potentially other events happening. Warning flashes can only be installed in the vicinity of schools or playing fields. Some other villages have VAS which can be moved around. She has asked the safety team to look up the historical speed data and do an up to date one. Mr. Etchells-Butler and Councillor Turner have another meeting to discuss. They consider that with the previously approved applications on this site, this additional proposal would result in overdevelopment of the area. The area is liable to flooding Additional vehicles exiting this site would present a hazard being sited close to the village hall entrance, and create additional traffic on the A1088.</p> | |
| | <p>7.2 DC/20/05005 Land South of Little Owl Lodge, Ashfield Road, Norton, Full Planning Application - Erection of 1No dwelling with parking. The Council objected to this proposed application. The application site is outside the current settlement boundary according to the Babergh and Mid Suffolk Joint Local Plan Regulation 19. Norton Little Green is a small hamlet around a mile and a half from the centre of the village and surrounded by open countryside. The proposal would therefore be further erosion of the open countryside and would set a likely precedent for future development in this area. The proposed application could not be considered to be in a sustainable location. The hamlet is of sufficient distance from the village amenities of Norton and Elmswell to require use of vehicular transport to access those amenities, ie school, village hall, play area and playing field, garage and shop, thus creating additional traffic flow along this small quiet minor road. There is very little public transport in this area. As there are currently two accesses to the site a condition to use only the access shown on the proposal needs to be stated if this application is given approval.</p> | |

Construction of vehicular accesses and associated works.</p> <p>The Council objected to this application on the following grounds:</p> <ul style="list-style-type: none"> • The application from 6 to 9 properties would represent overdevelopment of the site. • The proposed road layout gives concern for a potential increase in future development in this area. • The development is directly opposite Prospect Road, so with the increase in vehicles this would represent a safety hazard for the Children picked up by bus for the Upper School in this vicinity. • The additional traffic generated would represent a safety risk for children and adults walking along the road particularly to the primary school due to the lack of pavement along Ashfield Road. There is a blind bend at Common Corner which represents an additional hazard. • Additional traffic along this minor road using The Street, which in places is narrow, would pass the village school which is congested at times with parental vehicles. • Lack of infrastructure fails to support additional housing. There is little or no public transport, and the Primary School is full. The nearest shop is several miles away so car usage would be essential thereby increasing pollution. • These designs are not in keeping with the character of the village. • The Council recommend keeping the development to the currently permitted 6. | |

| | <p>1. Train update. Mr. Lenko stated he has now looked in detail at this project. He knows this project is a sensitive subject as there are a few residents not in favour. Mr. Sadler has an engine, track, carriages. He recommends scaling it down to a straight track, thereby reducing the cost of fencing and other items needed. An insurance quote received has been £750 and in speaking to Mr. Fakes there may be a way of getting some sponsorship. The far end of the track could be a rewinding area. The train can only carry 4 children at walking pace, so those waiting may get frustrated. He felt keeping it simple with no turntable or siding would create a nice attraction to compromise with other views in the village. Mr. Etchells-Butler stated his in-depth article in the Messenger did not forward any negative responses, so felt this project could be revisited after Christmas. When asked Mr. Etchells-Butler confirmed that Mr. Sadler and his team would meet the cost of the insurance. Mr. Fakes commented that as the economy emerges from COVID a sum of around £10,000 should not be too difficult to source later in the new year. Mr. Etchells-Butler felt there may be money available from the County and District Locality Budgets. Mr. Fakes suggested some form of Trust or Association may be an idea to monitor and oversee this project. Mr. Aket enquired whether sponsors would be prepared to put money into this project without getting anything back and gave his concern about the use of locality funding, being public money, being used for a private project. He stated in West Suffolk there is a dedicated officer who monitors the locality funding concerning efficacy and to ensure how it is spent.</p> | |
